

**TOWN OF LOCH LYNN HEIGHTS  
ORDINANCE 2025-01  
FY 2026 BUDGET ORDINANCE**

**WHEREAS**, Section 47 of the Town Charter requires the presentation of the proposed budget in May of each year and in accordance, the proposed budget was presented to the Council at a council meeting held on the 13th day of May, 2025; and

**WHEREAS**, the Town Charter requires a Public Hearing be held for the public to comment on the proposed operating budget, and in accordance was held on the 3rd day of June, 2025; and

**WHEREAS**, Section 55 of the Town Charter authorizes the Town Council to set a tax rate to meet anticipated expenditures.

**NOW, THEREFORE, BE IT ORDAINED AND RESOLVED**, that the Mayor and Council of the Town of Loch Lynn Heights hereby adopt the proposed budget and tax rate of \$0.32 per \$100 of the assessed valuation on all Real Estate Taxes and \$0.53 per \$100 of the assessed valuation on all Personal Property and \$1.00 per \$100 of assessed valuation on all Certification of Public Utility Taxes for the Fiscal Year 2025-2026; and

**BE IT FURTHER ORDAINED AND RESOLVED**, that from time to time the Town Council may find it necessary to transfer appropriated sums to purposes other than listed in the attachments to this Ordinance while retaining a balance between revenues and expenditures as set forth in Town Charter Section 50.

**IT IS FURTHER ORDAINED AND RESOLVED**, this ordinance shall be duly advertised in accordance with the Policy for the Adoption of Ordinances by the Mayor and Town Council of Loch Lynn Heights, and a public hearing on this Ordinance shall be held on the 3rd day of June, 2025, at 5:30 pm at the Town Hall located at 211 Bonnie Boulevard, Loch Lynn Heights, MD 21550.

**INTRODUCED:** This 13th day of May, 2025.

**SECOND READING AND ADOPTION:** This 3rd day of June, 2025.


**AND BE IF FURTHER RESOLVED**, this Ordinance shall be effective as of July 1, 2025.
