ARBOR DAY OBSERVED

The annual Loch Lynn Heights Arbor Day program was held on Tuesday, May 20. Katherine Phillips of the MD Dept of Natural Resources, assisted by the mayor, planted a red crab apple tree. She also examined some trees that are in need of removal. Our Town has received the DNR's Tree City designation for the past 17 years, and the Maryland Forest Service's PLANT Award for 18 years, for its commitment to caring for our community's trees.

Playground Renovation and Additions to Begin



Funding from grants including Project Open Space, Community Parks and Playgrounds, and the American Rescue Plan (Covid) will allow our park and playground to see major changes this summer and fall. New play equipment will replace the nearly 30year-old pieces in the original playground. In addition, a new, ADA accessible section will be installed over a poured rubber surface. It will include musical toys and inclusive pieces that are suitable for children with physical limitations or autism. A generous donation raised for "Landon's Dream" from the Georg family and Deep Creek Lions Club will make this inclusive area a reality. These funds were initially raised for a planned inclusive playground near McHenry, MD, but the costs for constructing an entirely new facility became too great. Adding this money to our playground renovation will allow young Landon Georg's vision to be realized. New swings and all new fencing will also be part of the work. Watch for updates on the town's website.

To go along with the ADA playground, much-needed new parking will be added at each end of the park area, including handicap spaces which will be connected by accessible paths. Input given by residents helped shape the new additions, and their suggestions are much appreciated.

SUMMER REMINDERS

Open burning is <u>not permitted</u> within Town limits. This includes burning of leaves, brush, or trash. Small cooking fires must be contained in a grill or fire pit and may use charcoal or dry wood. Fires that produce lots of smoke or foul odors are strictly prohibited, as they cause distress to residents who have breathing problems.

Garage or Yard Sale signs do not require a permit in Loch Lynn. 2 signs may be placed up to 48 hours before the sale, must be removed within 24 hours after the sale, and may **not** be posted on any traffic sign, utility pole, street light, or USPS mail box.



Zoning Permits

are required for most construction projects, including outbuildings, storage sheds, fences, sidewalks, garages, porches, pools (above ground or in-ground) and additions to existing buildings, etc. Call before starting a project to get info on **town laws** regulating Zoning and Construction. There are regulations regarding set-back distances from streets, alleys, town rights-of-way and neighbors' property lines. We are happy to assist you in complying with these ordinances.



PLEASE USE CAUTION

Children are playing

outdoors and riding bikes, and many will be utilizing the athletic fields through the summer and fall. Please drive carefully when children are present – the speed limit on Town streets is **25 mph**. You will be seeing speed indicators on main streets to remind drivers to slow down.



The Town's Pavilion is available for reunions, parties, etc. Rental of the pavilion requires a payment of \$50. If use of the bathroom and electric service is desired, an additional \$25 key deposit is collected, and refunded when keys are brought back. There is an adjacent playground and nearby walking trails that are available for use. Contact Town Hall for reservations or more information.

Changes Noted in GCPS Summer Food Services Program



The Garrett County Public Schools (GCPS) Food & Nutrition Services Department is happy to announce the return of the Summer Food Service Program. Distribution will be for seven days of free breakfasts and lunches and will begin the week of June 16, 2025.

There are some changes this year to the Summer Food Service program, due to Federal clarifications in the regulations. Families or a designated person must register to receive meals. Families can register using an online form (<u>https://forms.gle/SVJWiZd9L5xWgZXt7</u>) or at one of the meal sites. A list of meal sites can be found on the GCPS website

www.gcps.net/summer-food-service. Families that have not pre-registered will be required to bring their child(ren) or a report card with them the first time to pick up meals. Additionally, only two meals per day will be served this year. Seven days of breakfasts and lunches will be distributed per week. These meals will include fresh fruits and vegetables, milk, and entrees. All meals are free of charge to children 18 and under, regardless of whether they are enrolled in Garrett County Public Schools. Families from outside of Garrett County are welcome, but will need to preregister or bring their children with them. Additional information can be found at www.gcps.net.
